**E Responsible Gambling**

- 1) Voluntary Exclusion Program (VEP)
  - a) 41 new participants joined the casino VEP in September. The current number of active participants is 3,158.
  - b) There were 12 removals from the VEP in September for a total of 1,336.

- c) To date, 2,691 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.
  - d) There were 14 additional enrollments in the lottery VEP in September with 4 removals; the total number of participants is 739.
  - e) There are currently 545 participants in the bingo hall VEP.
  - f) There are currently 373 participants in the sports wagering VEP.
  - g) There are currently 343 participants in the fantasy competition VEP.
- 2) The annual staff webinar for responsible gambling has been created.
- 3) A MARG meeting was held at Ocean Downs Casino on Monday, September 23, 2024.
