- 1) ITLM Update As of 3/10/2025, 402 ITLMs in 91 unique Veterans' Posts are currently operational.
- 2) Monthly ITLM net sales in February 2025 (\$1,318,443) decreased by 4.8% compared to February 2024 (\$1,384,826).
- 3) Live! Casino submitted a request to convert the gift shop, located near the Prime Rib entrance, into an extension of the existing gaming floor and install 30 VLTs in the space. This expansion will add 923 square feet of new gaming area. The room will remain part of the current casino floor and will not introduce a new ingress or egress. IGT is prepared to support this request and has the site prepped. Live! Casino will adhere to the standard change request protocol for the installation of the VLTs and submit updated floor plans for approval. Renovations are scheduled for completion on or around April 7, 2025.

E Responsible Gambling

- 1) Voluntary Exclusion Program (VEP)
 - a) 52 new participants joined the casino VEP in February. The current number of active participants is 3,280.
 - b) There were 27 removals from the VEP in February for a total of 1,428.
 - c) To date, 2,851 violations have occurred since the casino VEP began. All violators are subject to criminal trespass charges.
 - d) There were 19 additional enrollments in the lottery VEP in February with 3 removals; the total number of participants is 780.
 - e) There are currently 625 participants in the bingo hall VEP.
 - f) There are currently 464 participants in the sports wagering VEP.
 - g) There are currently 430 participants in the fantasy competition VEP.
